Shimla vide Notification No.-Shiksha-II-Chha(11)-2/2005-L dated 03-05-2006 and in exercise of the powers vested in me vide Govt. Notification No. Shiksha-II-Chha-(5)-3/97 dated 16-01-2007, the approval of competent authority with regard to issue of Permission for establishment/running/up gradation of private Educational Institution in respect of "लौरेट एजूकेशनल सोसाइटी, ब्रांस-पैथ, भराइी, शिमला-1" registered under as per the provision of Registration Act, 1860 (Registration No.-2/1993) dated 12-03-1993 for the establishment of "Laureate Public School Bharari, Shimla, Brance-Peth, Bharari, Shimla H.P.-171001" for 9th to 10+2 (Arts, Commerce & Science Stream) classes from the academic session 2020-21 (if the affiliating Board find fit) is conveyed subject to the following terms and conditions:-

- 1. That the school concerned shall be affiliated to Central Board of Secondary Education Shiksha Kendra-2, Community Centre, Preet Vihar, Vikas Marg, Delhi-110301 for 9th to 10+2 (Arts, Commerce & Science Stream) classes.
- 2. That the State Govt. will not provide any type of financial assistance/Grant-in-aid etc. in respect of the said institution.
- 3. That the admission in the institution shall be made strictly in accordance with the norms as laid down by the Board of School Education to which the school is affiliated and no discrimination on the basis of caste, colour, creed and sex shall be made. No pupil shall be refused admission on account of his caste, creed or religion.
- 4. That the private institution shall employ only the trained/eligible staff as per the norms fixed by the Govt.
- 5. That no particular religious education shall be impacted by the institution to maintain secular character of the institution.

- 16. That the Society will provide the facility of provident fund as per the EPF norms to its staff and will take up welfare programme for the employees and students as well.
- 17. That the Manager shall, within six months after the end of the every Academic year, submit to the competent authority the report of Chartered Accountant on the Audit of the Accounts under sub-section (1).
- That the concerned school will also not charge fee towards Building fund, Infrastructure fund and development fund etc. from the students/parents.
