





This No.O.C. is issued subject to the
following conditions.

1. No pupil shall be refused admission on account of his caste creed or religion and the pupil who has once been admitted shall not be treated differently from the other fellow pupils of his caste creed or religion.
2. No pupil shall be compelled to attend a class in which a religious instruction is given or take part in any religious exercises.
3. The school with its account books, registers and other records shall be open to inspection at all reasonable hours by the authorised officer of the Department, Executive Officers of the Govt. authorised to inspect schools and Health Officer deputed by the Health Department to examine the health of the students or sanitary condition of the building and premises.
4. The schools shall have to furnish all information and returns as called for by the Department from time to time.
5. The school shall comply with the rules of the Department and directions as given by the department so far as they are applicable to private schools in the interest of maintaining education standard. The Director of Education shall have the authority to send any of his officer for inspection for proper maintenance of educational standards, holiday as per State Govt. etc.
6. The school staff and students shall not take part in any agitation directed against the authority of Govt. or disseminate opinions tending to excite feelings of disloyalty or disaffection against the Govt. or of enmity and hatred between different communities.
7. The School shall charge the rates of tuition fee and subscription to boys funds in accordance with the scales prescribed or approved by the Education Department of H.P./CBSE/ICSE and schools shall have to submit a classwise list of tuition fee and funds to this Directorate.

8. The schools shall maintain the discipline properly.
9. The school shall take steps to promote the use of Hindi. The extent of reservation for SC&ST students at the time of admission to be adhered to.
10. The school shall have to work within the framework of National priorities.
11. In the matter of appointments of teaching/non-teaching staff preference will be given to the Himachalis.

The breach of any of the conditions specified above shall render the school defaulter and the Director of Education after conducting any enquiry through any of the officers so designated by him, shall have the power to cancel the N.O.C.

Grant of permission to run/establish of a private educational institution.


On the careful consideration of the inspection report submitted by the Inspection Committee District Shimla vide letter No.-Shiksha-SML(5-2)B-PS/NOC/2019-238418-19 dated: 16-07-2019 constituted for the purpose of inspection of Private Educational Institutions of the School level for grant of permission to run/establish a private educational institution by the Govt. of H.P. Shimla vide Notification No.-Shiksha-II-Chha(11)-2/2005-L dated 03-05-2006 and in exercise of the powers vested in me vide Govt. Notification No. Shiksha-II-Chha-(5)-3/97 dated 16-01-2007, the approval of competent authority with regard to issue of Permission for establishment/running/up gradation of private Educational Institution in respect of "लौरेट एजुकेशनल सोसाइटी, ब्रांस-पैथ, भराड़ी, शिमला-1" registered under as per the provision of Registration Act, 1860 (Registration No.-2/1993) dated 12-03-1993 for the establishment of "Laureate Public School Bharari, Shimla, Brance-Peth, Bharari, Shimla H.P.-171001" for 9th to 10+2 (Arts, Commerce & Science Stream) classes from the academic session 2020-21 (if the affiliating Board find fit) is conveyed subject to the following terms and conditions:-

1. That the school concerned shall be affiliated to Central Board of Secondary Education Shiksha Kendra-2, Community Centre, Preet Vihar, Vikas Marg, Delhi-110301 for 9th to 10+2 (Arts, Commerce & Science Stream) classes.
2. That the State Govt. will not provide any type of financial assistance/Grant-in-aid etc. in respect of the said institution.
3. That the admission in the institution shall be made strictly in accordance with the norms as laid down by the Board of School Education to which the school is affiliated and no discrimination on the basis of caste, colour, creed and sex shall be made. No pupil shall be refused admission on account of his caste, creed or religion.
4. That the private institution shall employ only the trained/eligible staff as per the norms fixed by the Govt.
5. That no particular religious education shall be imparted by the institution to maintain secular character of the institution.
6. That the fees and funds shall be such that they are not of exploiting nature but contribute to the spread of education. They should be commensurate to the salary of the staff being paid, development of infrastructure and facilities and activities being provided to the students. (Donation in any form from the student is strictly prohibited).
7. That the permission to run or establish a private educational institution shall be granted only on individual basis and the institution shall not be entitled to open its branches elsewhere.
8. That the institution shall maintain proper record accounts and register in accordance with norms of HP Govt. As stated in chapter III of the Himachal Pradesh Private

Educational Institutions (Regulation) Act, 1997 and Notification No. Shiksha-II-(Ga) 6-1/98 dated 10-06-2008 Corrigendum of the same and will submit the annual report to the Director of Higher Education as prescribed under the Act.

9. That the institutions shall have to comply with the norms/provisions of the H.P. Private Educational Institutions (Regulation) Act, 1997 and rules notified by the Govt. vide notification No. Shiksha-II-(Ga)6-1/989 dated 19-10-2004 corrigendum dated 10-06-2008 and the instructions issued by the competent authority from time to time.
10. That the school shall have to furnish all information and returns as called for by the Department from time to time.
11. That the society will make efforts to acquire its own land and establish the institution in its own land.
12. That the recruitment of staff will be made after following proper procedure i.e. by advertisement at least in two leading national daily newspaper and getting sponsorship of names from the nearest employment exchange giving full detail of the qualifications required and scales of pay plus allowances payable by the school.
13. That the salary of staff is to be paid strictly through RTGS/on line system only.
14. It should be mentioned noticeably/highlighted in the prospectus of the institution, details of the staff & their qualifications, fees, funds and other relevant information about the institutions and information regarding grant of permission of the Govt. To establish and run the institution.
15. That the name of the affiliating Board of the institution should be mentioned in the prospectus with Approval No. Registration No. And Affiliation No. the same should also be displayed on the notice boards of the institutions, at least 2-3 places visible easily to all.
16. That the Society will provide the facility of provident fund as per the EPF norms to its staff and will take up welfare programme for the employees and students as well.
17. That the Manager shall, within six months after the end of the every Academic year, submit to the competent authority the report of Chartered Accountant on the Audit of the Accounts under sub-section (1).
18. That the concerned school will also not charge fee towards Building fund, Infrastructure fund and development fund etc. from the students/parents.


